In accordance with our agreed terms of engagement, we have performed an engagement on the attached consolidated income and expenditure account of the Association's general charitable fund-raising activities held during 18 August 2012 to 19 August 2012 and 25 August 2012 to 26 August 2012 ("the Events").

***Respective responsibilities of the management and ourselves***

The association's executive committee is responsible for preparing the attached consolidated income and expenditure account in accordance with the basis of preparation set out in note 2, setting out the gross subscriptions raised from the Events and the expenses incurred in connection with the Events, in order to comply with the conditions stated in the Public Subscription Permit issued by the Social Welfare Department of the Government of the Hong Kong Special Administrative Region ("SWD"). This responsibility includes designing, implementing and maintaining internal controls relevant to the preparation and presentation of the consolidated income and expenditure account so that it reflects the subscriptions raised and expenses incurred in connection with the Events and is free from material misstatement.

It is our responsibility to form a conclusion on the attached consolidated income and expenditure account, based on our engagement, and to report our conclusion to you.

***Basis of conclusion***

We conducted our engagement in accordance with Hong Kong Standard on Assurance Engagements 3000 "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to the "Circular on Reporting on General Charitable Fund-raising Activities Covered by Public Subscription Permits issued by the Social Welfare Department (Other than Flag Days)" issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). The work undertaken in connection with this engagement is less in scope than an audit conducted in accordance with Hong Kong Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

Furthermore, due to the nature of cash receipts and expenses relating to general charitable fund-raising activities, it was not practicable for us to determine whether the consolidated income and expenditure account and the books and records of the Association include all transactions relating to the Event. It was impracticable for us to quantify the potential impact of this on the consolidated income and expenditure account. Accordingly, our report relates solely to the consolidated income and expenditure account prepared from transactions that have been recorded in the Association's books and records.

Our engagement included carrying out limited procedures for obtaining sufficient appropriate evidence to be able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting matters and other procedures we considered necessary.

***Conclusion***

Based on the foregoing, we report that nothing has come to our attention that causes us to believe that the attached consolidated income and expenditure account does not reflect, in all material respects, the gross subscriptions raised and the expenses incurred by the Association in respect of the Events that have been recorded in its books and records made available to us in accordance with the basis of preparation set out in note 2.
